

CUMMINS BRANDED MOBILE COMMUNICATION AND TECHNICAL ACCESSORIES

ONE YEAR LIMITED WARRANTY

This Limited Warranty covers *Cummins Branded Mobile Communication and Technical Accessories, including mobile chargers, cables, charging “blocks”, phone cases, tablet cases, ear buds, earphones, headphones, headphone and microphone headsets, Bluetooth speakers and FM transmitters (hereinafter an “identified product” or collectively “identified products”)*. These identified products are warranted against defects in materials and workmanship for a period of ONE (1) YEAR from the date of original retail purchase ("Warranty Period"). This warranty extends only to the original purchaser and will end when the identified product is transferred to a subsequent owner. If a defect arises during the Warranty Period, DAS Companies, Inc., at its option and to the extent permitted by law, will: (1) replace the identified product with a new product as the same purchased; or (2) exchange the identified product with a functionally equivalent product that is new. This warranty excludes damage resulting from misuse or abuse, accident, operation of the identified product not in accordance with the manuals or other included written instructions, modification of the identified product, attempted repair of the identified product, or as a result of an act of God or as a result of war or terrorist attack or other causes that are not defects in materials and workmanship.

Non-Cummins branded products/Third Party Products. This warranty does not apply to products that are not Cummins branded even if packaged or sold with Cummins branded products, nor does it apply to batteries or similar expandable parts or accessories.
